Unusual fire/explosion hazards

To minimise the generation of red hot swarf ensure that a sufficient flow of oil is correctly directed to the cutting edge of the tool to flood it throughout cutting operations. As an additional precaution swarf should

be regularly cleared from the immediate area to prevent the risk of fire.

Protection of fire-fighters

Handling - Protective measures
