**2. COMPOSITION/INFORMATION ON INGREDIENTS**

**Mixture Description** : Highly refined mineral oils and additives.

**Additional Information** : The highly refined mineral oil contains <3% (w/w) DMSO-extract, according to IP346.

**3. HAZARDS IDENTIFICATION**

**EC Classification** : Not classified as dangerous under EC criteria.

**Health Hazards** : Not expected to be a health hazard when used under normal conditions. Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis. Used oil may contain harmful impurities.

**Signs and Symptoms** : Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.

**Safety Hazards** : Not classified as flammable but will burn.

**Environmental Hazards** : Not classified as dangerous for the environment.

<b>Respiratory Protection</b>	: No respiratory protection is ordinarily required under normal conditions of use. In accordance with good industrial hygiene practices, precautions should be taken to avoid breathing of material. If engineering controls do not maintain airborne concentrations to a level which is adequate to protect worker health, select respiratory protection equipment suitable for the specific conditions of use and meeting relevant legislation. Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material. Glove thickness should be typically greater than 0.35 mm depending on the glove make and model.
<b>Eye Protection</b>	: Wear safety glasses or full face shield if splashes are likely to occur.
